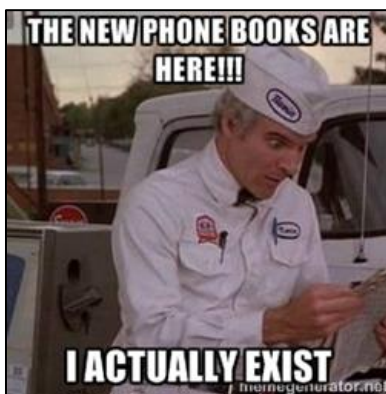
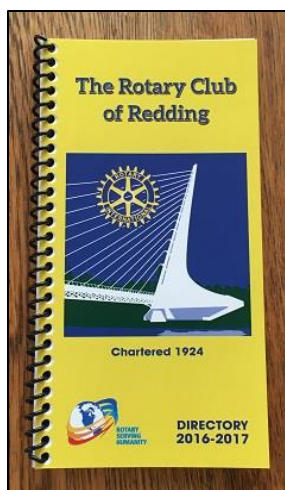
Sunshine Report: **Mary Brace's** sister passed away suddenly. Please keep **Mary** in your thoughts and prayers during this very difficult time.

Program: **Ed Rullman** introduced **Laurie Baker**, the General Manager for the Shasta-Cascade Wonderland Association (SCWA). Through a contract with the City of Redding, the SCWA operates the Redding Convention & Visitors Bureau (RCVB). The RCVB is a marketing organization for the City of Redding created to add tax and general fund revenue by promoting tourism in Redding and the surrounding areas. With increased tourism comes increased transient occupancy taxes (TOT) paid by visitors to the area. Increases in TOT paid by visitors frees up for other governmental uses tax monies paid by local residents. RCVB markets Redding nationally and internationally in many different ways, such as digital, radio, and television advertising, as well as print advertising in magazines including Sunset, National Geographic, and Via. RCVB has even placed advertising on United Airlines Flights to promote Redding. There are also plans to put a "Pokemon Go" map on RCVB's website.
