

Bethel Church's Public Investment



Kris Vallotton is the Senior Associate Leader at Bethel Church, and the Board Chair of Advance Redding, the operator of the Civic Auditorium. He visited our club to share information about Bethel Church and their recent donation of \$500,000 toward the City of Redding to support funding for Redding's Neighborhood Police Unit.

Bethel has adopted an idea of what a noble city should be like, and this donation was in an effort to help create that idea in Redding. They feel strongly

about their church being positively involved in the community.

Bethel's Ten Signs of a Noble City:

- 1. The city is safe. You are not worried about your children being harmed or your home being broken into. When someone does commit a crime they are brought to justice swiftly.
- 2. The city is prosperous. Industry is thriving and there are plenty of well paying jobs for everyone who wants to work. Therefore, unemployment is low and there is enough tax money to pay for all the necessary services.
- 3. The educational institutions are excellent. They are training and equipping students in both life skills and occupational opportunities.
- 4. There is a positive spiritual climate in the community led by many healthy churches.
- 5. The morale of the city is high. People have a positive outlook on life and they are generally happy.
- 6. The medical community is well-equipped and staffed to help bring physical wholeness to people.
- 7. There is healthy recreation and entertainment in the community.
- 8. The government of the city is honest, forward thinking, and wise.
- 9. The city has a noble identity and purpose.
- 10. The poor and homeless are well taken care of.

"The answer to our crime problem isn't going to be four police officers. But think about the crime rate when we take away the only four officers in the city who are taking preventive measures," said Vallotton.

When facing this thought, Bethel took \$500,000 from a capital project fund they've been saving and transferred it to the City. They've also committed an additional \$50,000 toward a fundraising campaign to raise the rest of the money needed by the City to keep those four officer positions.


