Some of the ideas being considered to address these five central ideas include the following: (1) Achieve a balanced budget and establish a ten year financial plan; (2) Maximize the effectiveness of the City's limited resources through use of technology, regular assessment of activity and results, ensuring adequate training, and seeking and following best public safety practices; (3) Employ a variety of mediums to communicate and interact with the public; (4) Explore the greater use of citizens in a review or advisory capacity for traditional government functions, such as budget creation, rate-making, and cost-cutting; and (5) Identify barriers to economic development within the City's processes and develop, implement, or propose improvements. 


