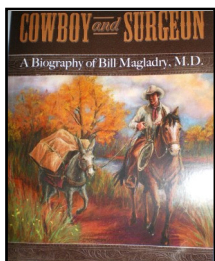


This Week's Meeting

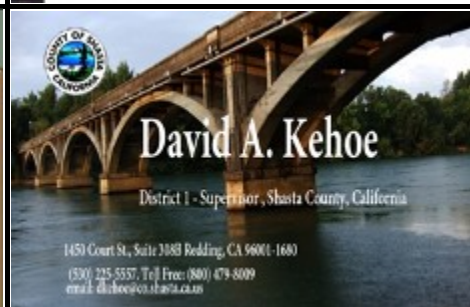
