Program - The STEP-UP Program

Eva Jimenez introduced and led our program today, Shasta College's STEP-UP Program (Shasta Technical Education Program United Partnership)

The Program is actually a partnership between the College, the Shasta County Sheriff's Department, Shasta County Probation Department, the Good News Rescue Mission, and the Children's Heritage YouthBuild Academy (CHYBA).

The mission of Step-Up is to reduce recidivism in our community by providing a high-quality college and career pathway for individuals that are currently incarcerated or have a history of previous incarceration.

This incredibly successful program started in 2012 with a cohort of 10 students. As of the Spring 2018 term there are 100 students participating in the Program.

Current highlights of the Program include:

- 69 males/31 females
- F2017 GPA = 3.07 (23 students with 4.0 GPA)
- 27 students made the Dean's List for the F2017 term (3.5 GPA or higher)
- 25 students scheduled to graduate in the 2017/18 academic year

An important concept being exercised with the Program is that of restorative justice, which is defined as: "a theory of justice that emphasizes repairing the harm caused by criminal behavior. It is best accomplished through cooperative processes that include all stakeholders. This can lead to transformation of people, relationships and communities".

STEP-UP provides academic support, campus & tuition fees, textbooks & materials, and meals on campus to its participants.

Three of the Program's participants were in attendance and spoke about their rocky past and how STEP-UP has provided a fresh opportunity for their success.

One notable quote from one of the participants named John was:

"Failure is an event, not a person"


