

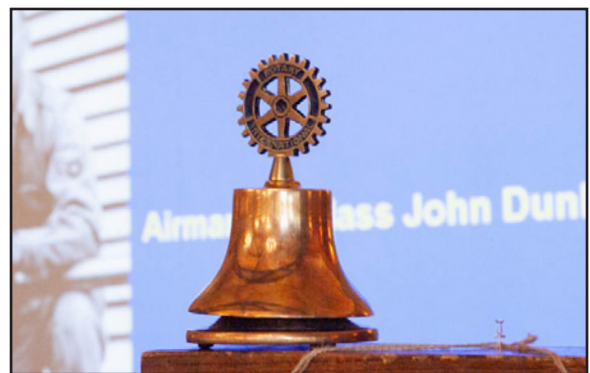


Honoring Our Veterans

Today's Program - Honoring our Veterans

Greg Balkovek started our program with a brief history of the celebration of Veteran's Day. In 1918, on the 11th hour of the 11th day of the 11th month, an armistice was declared between the Allied nations and Germany in World War I. The following year, **U.S. President Woodrow Wilson** proclaimed November 11th as the first commemoration to honor the soldiers who fought in that war. The day was originally known as Armistice Day. November 11th became a federal holiday in the United States in 1938. In the aftermath of World War II and the Korean War, the holiday became known as Veterans Day.

Tom Stovall announced the Club's newest inductee to our roll of honored veterans. Each year, the most senior veteran in our club who has yet to be added to this list, is that year's inductee. This year we were pleased to recognize **Airman First Class Robert (Bob) Anderson**. Additionally, **Bob** was conferred with Redding Rotary's Medal of Freedom award by **President Elect Jake Mangas**, and **Shasta County Supervisor Chairman Leonard Moty** presented **Bob** with an Award of Excellence from the County for "courage, honor, and patriotism".

- Say "thank you for your service" - it is encouraging and honoring for them
- Be aware of their personal space - startling actions or noises can be disturbing
- Don't ask "did you kill someone?"
- If they are ready, ask to hear their story - listen and don't be judgmental


