Thanks to **Rick Hill** for opening our meeting with *Here Comes the Sun*

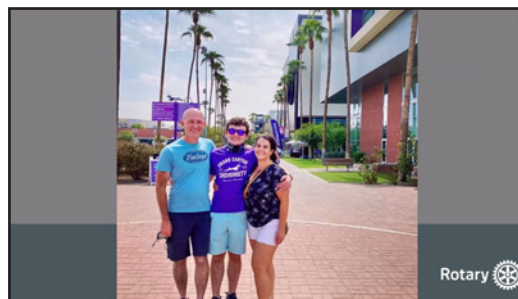
Announcements

Today's Program - Community Foundation of the North State Update

President Jake introduced today's presenter, **Kerry Caranci**, CEO of the Community Foundation of the North State. He noted his personal connection with the Foundation as being a board member, and also mentioned the fund that he and his family established to honor the passing of his son Michael.

Formerly known as the Shasta Regional Community Foundation, **Kerry** discussed the transition to a new name - The Community Foundation of the North State. This change was taken to help clarify who the organization is and who they serve. Now in its 20th year, the Foundation has grown its service area to include Siskiyou and Tehama counties.

Kerry noted the year-long plus process of working through the rebrand process and gave some kind kudos to **Bret Christensen** and his company Pacific Sky for their partnership. **President Jake** didn't miss the opportunity to fine **Bret** \$100 for this recognition by **Kerry**.

As part of the "reveal" process of the new brand, the Foundation chose to celebrate by holding a contest to give away \$15,000 to local non-profits. The competition was set up to benefit one non-profit each in the three counties they serve.

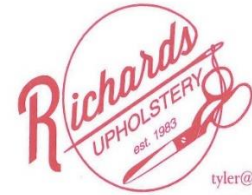
