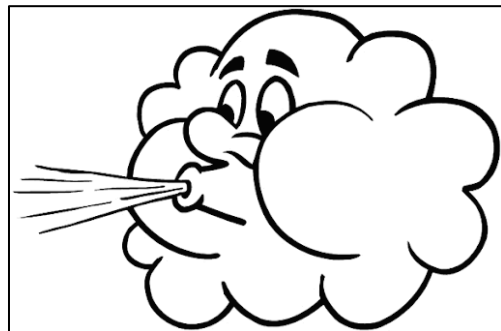

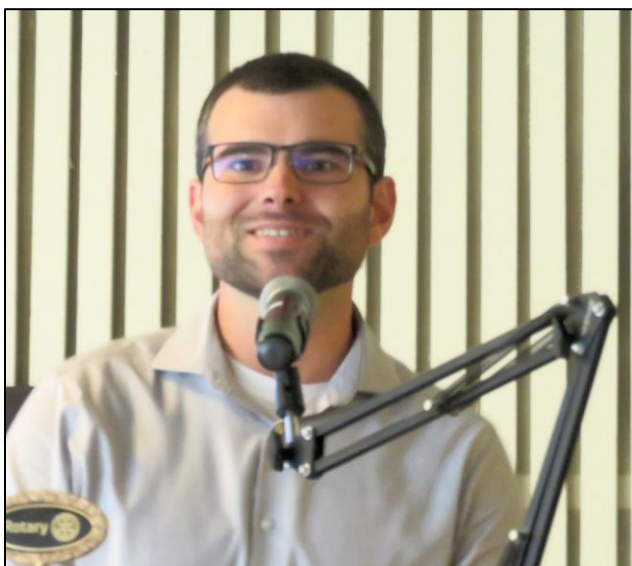
### Recognitions:

**Henry Woltag**

**Program:** **Michelle Nystrom** introduced **Henry Woltag**, a Director of Development with ConnectGen to inform the Club about the Fountain Wind Project. The Fountain Wind Project is a proposed wind farm in Eastern Shasta County with up to 48 turbines. According to **Henry**, the project is a “clean, low-cost, low-impact energy source.” **Henry** also expressed that ConnectGen is willing to donate roughly \$2.8 million in community contributions. **Henry** also stated that the project will “provide significant long term revenue for the County” and that it will “have significant fire safety systems in place at the project site.” In answering questions from Rotarians, it was noted that community members have expressed concerns about the project’s visual impacts, as well as other concerns. ConnectGen’s application for a use permit was denied by the Planning Commission on a 5-0 vote. As a result, ConnectGen revised the project. The matter has now been appealed and will be considered by the Board of Supervisors on October 26.
