



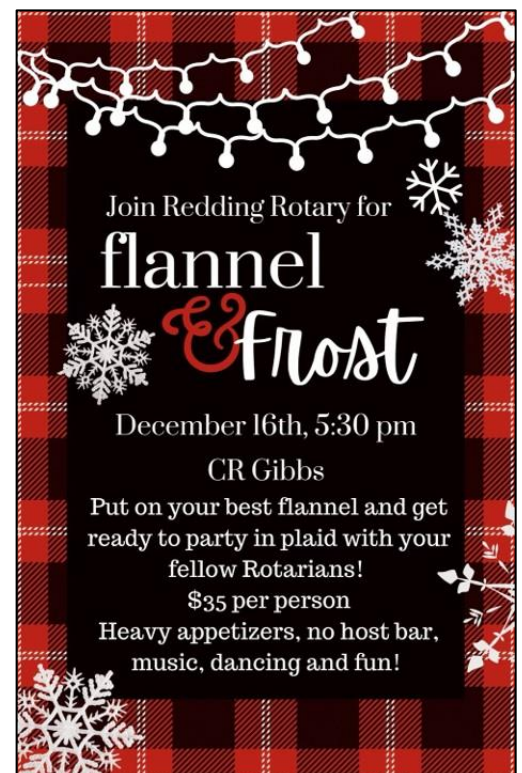

Program: **Jake Mangas** introduced **Todd Jones**, President of the Shasta County Economic Development Corporation (EDC). **Todd** provided the Club with an update concerning the EDC's activities. The primary objectives of the EDC are business recruitment, business retention and expansion, increased air service, and scalable start up support. Through the EDC's efforts, there has been an increase in air service through the Redding Airport, with three airlines providing service to San Francisco, Los Angeles, Seattle, Burbank, and soon Las Vegas. There has also been an increase in interest in Stillwater Business Park, with 270 acres being sold in the last 18 months. There have also been some other recent business proposals, with six projects potentially bringing 1,681 jobs and \$614 million in investment. The EDC has also sponsored various events, such as the "The Start Up Games," and the upcoming Redding Venture Conference scheduled for April 8, 2022 at the Redding Sheraton Hotel. As **Todd** stated, "The goal is to make Shasta County the best place in the country to do business." 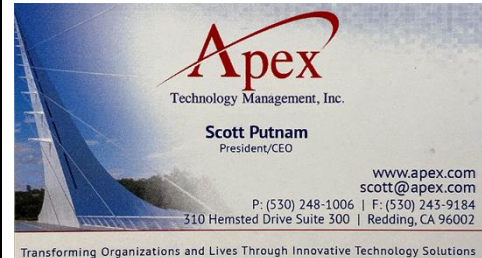

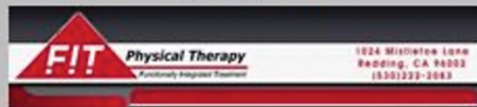
