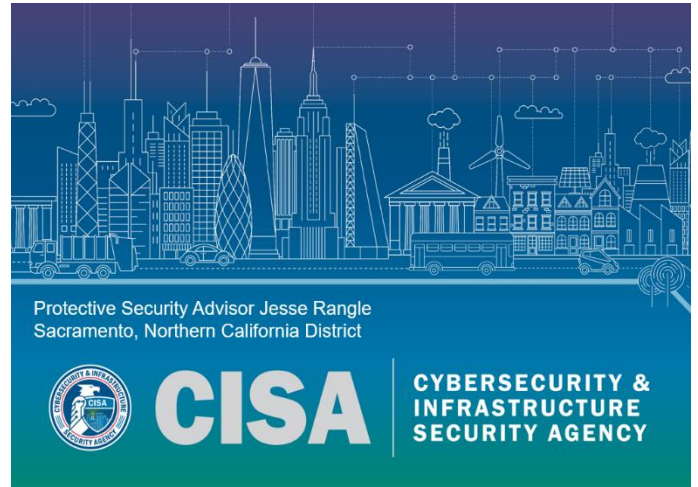

CYBERSECURITY & INFRASTRUCTURE SECURITY AGENCY

Joshua Johnson introduced today's speaker, **Jesse Rangle** of the Cybersecurity & Infrastructure Security Agency (CISA). As America's Cyber Defense Agency and the National Coordinator for critical infrastructure resiliency and security, CISA leads the national effort to understand, manage, and reduce risk to the cyber and physical infrastructure that Americans rely on every hour of every day.

Jesse is the DHS CISA Region IX Sacramento, Northern California District Protective Security Advisor. With a title like that who needs a job description. **Jesse's** bio is far too lengthy to provide here; however has been deeply involved in emergency management at the federal level for over 35 years.



Considering for a moment the vulnerable nature of our power grid, water and food supply, transportation and waste management systems and commercial facilities, an effective assault on any of these could have devastating effects on our daily lives. This is what **Jesse** wakes up every day to protect against. His biggest point... if you see something, say something.



Protective Security Advisors have five mission areas:

- Plan, coordinate, and conduct security surveys and assessments.
- Plan and conduct outreach activities with critical infrastructure owners and operators, community groups, and faith-based organizations in support of CISA priorities to include Active Shooter, De-Escalation, and Behavioral Threat Assessment & Management Training.
- Support National Special Security Events (NSSEs) and Special Event Activity Rating (SEAR) events.
- Respond to incidents.
- Coordinate and support improvised explosive device awareness and risk mitigation training.


